Waiver, Release, Assumption of Risk, and Indemnity Agreement

I am the parent or guardian of the minor named above (the “*Player*”). I wish to register the Player with the Pelham Recreation Ice Hockey, Inc. (doing business as the Pelham Youth Hockey Association) (the “*Association*”) and, by this agreement, I give my permission for the Player to participate in all Association activities (including, but not limited to, tryouts, practices, games, tournaments, off-ice training, team social events, and transportation to and from any of the foregoing).

I, on behalf of the Player, on my own behalf, on behalf of my spouse or any other legal guardian of the Player, and on behalf of each of our respective heirs, executors, administrators, and assigns (each, a “*Releasor*”, and collectively, the “*Releasors*”), in consideration of the Player’s registration with the Association and being allowed to participate in Association activities, unconditionally, irrevocably, and fully release, waive, acquit, and discharge the Association and its member teams and affiliate associations, USA Hockey, Inc., New York State Amateur Hockey Association, Inc., the Hudson Valley Hockey League, the Town of Pelham and its Town Council, the Pelham Recreation Commission, the Pelham Union Free School District and its Board of Education, the venue, host, officials, sponsors, and other participants of events in which the Association or any of its teams participates, and each director, officer, employee, coach, volunteer, and agent of each of the foregoing (each, a “*Releasee*”, and collectively, the “*Releasees*”), from all claims, actions, causes of action, proceedings, suits, damages (including, but not limited to, direct, indirect, incidental, consequential, special, and punitive damages), judgments, liabilities losses, costs, expenses (including, but not limited to, attorneys’ fees and disbursements), and demands of any kind, nature, or description whatsoever, whether for property damage, personal injury, wrongful death, or otherwise, whether caused by the negligence of any Releasee or any other person, and whether known or unknown, suspected or unsuspected, anticipated or unanticipated, direct or indirect, fixed or contingent (collectively, “*Damages*”), that any Releasor ever had, now has, or hereafter can, shall, or may have against any Releasee for, upon, or by reason of any act, omission, transaction, occurrence, matter, cause, or thing of any kind, nature, or description whatsoever arising out of, in connection with, or in any way related to Player’s participation in any Association activity or the sport of ice hockey or any event or activity incidental thereto; except, with respect to any specified Releasee, to the extent directly attributable to the gross negligence or willful misconduct of such specified Releasee.

I understand, appreciate, and acknowledge that the Player’s participation in the sport of ice hockey and other Association activities will involve significant risks and dangers to the Player’s person, including, but not limited to, bodily injury, partial or total disability, paralysis, and death. I understand, appreciate, and acknowledge that such risks and dangers, while they may be mitigated by particular rules, equipment, and personal discipline, do exist. I understand, appreciate, and acknowledge that such risks and dangers include, but are not limited to: (i) that others, including any Releasee, may have been negligently selected, trained, or supervised, or may act or fail to act negligently; (ii) that venues (including, but not limited to, ice rinks) where Association activities take place, and the premises on which they are located, may not have been or may not be properly maintained, inspected, supervised, or controlled; and (iii) that injury may result or be more likely to result from participation in the sport of ice hockey with bigger, faster, or stronger players (and that this risk would increase significantly if the Player were to participate in activities with players in higher divisions, tiers, or age groups). I understand, appreciate, and acknowledge that there may be risks and dangers not known to the Association or another Releasee or not reasonably foreseeable by the Association or another Releasee at this time. By registering the Player with the Association and permitting the Player to participate in Association activities, I, on behalf of each Releasor, assume all such risks and dangers, including any caused by the negligence of the Association or any other Releasee, both known and unknown, and agree that any Damages arising out of any such risks or dangers are included within the scope of the release contained in the immediately preceding paragraph.

I, on behalf of each Releasor, give permission for the Player to receive any and all qualified emergency medical attention or treatment necessary, appropriate, or desirable to be administered in order to preserve the life, limb, or well-being of the Player until such time as I or another parent or guardian of the Player can be contacted, and authorize any Association officer, coach, or agent to transport the Player as required to receive any such medical attention or treatment. I, on behalf of each Releasor, understand and agree that neither the Association nor any other Releasee is obligated to maintain medical or hospitalization insurance coverage with respect to any Association activity or player, including the Player, and that each Releasor will be jointly and severally liable for the costs of any such medical attention or treatment.

I, on behalf of each Releasor, agree that if any action, suit, or proceeding based in whole or in part on any Damages (whether for property, damage, personal injury, or wrongful death or otherwise) arising out of, in connection with, or in any way related to Player’s participation in any Association activity or the sport of ice hockey or any event or activity incidental thereto (except, with respect to any specified Releasee, to the extent any such any action, suit, or proceeding relates to Damages directly attributable to the gross negligence or willful misconduct of such specified Releasee) is threatened or commenced against any Releasee, each Releasor will jointly and severally defend, indemnify, and hold harmless such Releasee from and against all such Damages (including reasonable attorneys’ fees and disbursements incurred in connection with responding to any such threat or defending against any such action, suit, or proceeding).

If the law in any controlling jurisdiction renders any part of this agreement unenforceable, the remainder of this agreement will nevertheless remain enforceable to the fullest extent, if any, allowed by controlling law.

I, on behalf of each Releasor, acknowledge that I have read, understand, and agree in full to the terms and conditions of this waiver, release, assumption of risk, and indemnity agreement, as well as the waiver, release, assumption of risk, and indemnity agreement entered into when registering the Player with USA Hockey. I, on behalf of each Releasor, represent that no Releasor has relied upon any representation of any Releasee with respect to the legal meaning or effect of either such agreement. I, on behalf of each Releasor, further understand and acknowledge that the waivers, releases, and indemnities provided for by this agreement are necessary to allow amateur ice hockey to exist in its present form, and to allow the Association to operate on the basis it currently operates.
